- The President or Appointee for every CWL Parish Council must forward a list containing names of the president, treasurer, spiritual advisor and membership convenor. This may be done through emailing info@cwl.ca, regular mail or online membership.
- In an election year, the President or Appointee must send notification advising **National Office** about newly elected/appointed executive positions.
- If there is a change during the term of contract or position, including the spiritual advisor, notify **National Office** as soon as possible.
- If a past president receives an email or package containing the parish council information, she should pass it on to the current parish council president immediately and ask her to advise national office of the change in position.
- Once Parish Council Presidents receive the "Mailings", they should separate the
 information and pass them on to the respective officers and chairpersons to allow
 sharing date-sensitive information in a timely manner.

As we look forward to celebrating the 100th Anniversary of the League, let us use that longevity and sustaining power as catalysts to personally invite a great influx of new members.

Doreen Gowans, National Communication Chairperson shared this in her communique #8 and I thought it should be shared again. "The Gift of Presence: The true meaning of Christmas, the birth of Jesus has been lost in many homes today. With all the hustle and bustle, it can be the busiest season of the year, as we rush out to purchase gifts, groceries and all the necessities we think are necessary to have everything perfect for our family and guests. However, sometimes we overlook the little ones (our children and grandchildren) and their needs. Take the time to be present with our loved ones, our families. Take the time to communicate your plans to your families so they don't become stressed unnecessarily. Where possible get them involved. Communication can be a big stress relief and it can be comforting if we handle it properly. Take the time to review Christmas plans with your families ensuring they understand your needs and expectations."

From Communique #9. "Council Registers: How does a council notify national office of a change to its executive listing? National office requires a complete list of names for all provincial and diocesan executive members and their contact information and, for parish councils, a list of the president, treasurer, spiritual advisor and membership convenor, including their contact information. This may be done through e-mail to info@cwl.ca, regular mail or, for parish councils, through the online membership process.

Mailings: An issue has come to light where some councils report not receiving council mailings along with other information sent from national office. The last mailing was sent via e-mail to parish council presidents on September 28, 2019. Encourage your diocesan counterpart to check if parish councils in their area received the fall mailing. The steps below indicate how the mailing should be dispersed to ensure a better flow of communication:

- 1. If a past president receives the e-mail or package containing the parish council information, she passes it on to the current parish council president as soon as possible and asks her to advise national office of the change in position.
- 2. Once the parish council president receives the information, it is her responsibility to separate the information and pass it on to the respective officers and chairpersons.
- 3. The officers or chairpersons, in turn, share the information in a short report with members at the next parish council meeting, or as soon as possible.
- 4. Date sensitive information is required to be shared in a timely manner as necessary."

EDUCATION & HEALTH Sheila Bielawski

One of the tasks of the Education and Health Standing Committee is to study and promote ecologically sound practices. We must continue to educate ourselves in ways to protect and preserve the earth's resources. The focus in year one of the national theme "Care for Our Common Home" was water. We became more aware of this valuable resource and how it is being used or misused. Some communities in our own country do not have access to clean drinking water, millions of litres of water are being sold by large corporations and due to climate change water levels are rising especially along coastlines. Each of these issues has a profound effect on poor communities.

World Water Day is celebrated on March 22nd. It is about water and climate change and how the two are linked.

The focus for the second year of the national theme "Care for Our Common Home" is the League is partnering with Catholic Near East Welfare Association to support the Pieta Bhavan project. This is outlined on page 20 of the winter edition of The League magazine.

Another date to be aware of is April 22nd. This is Earth Day and the 2020 theme is Climate Action.

The first full week of May is known as National Hospice Palliative Care Week in Canada. Councils are encouraged to participate in the 12 Hours of Prayer for Palliative Care to call on the power of prayer to make hospice and palliative care available to all Canadians.

LEGISLATION Karen McKibbon

In January 2020, Canadians were invited to respond to a federal government **on-line consultation** regarding Medical Assistance in Dying, (MAID) from the Federal Justice Department. CWL members were encouraged to respond to the questions, albeit in a short time frame. These consultations are to inform the Government's next steps in responding to recent court rulings regarding the medical assistance in dying framework.

The Court's ruling will come into effect on March 11, 2020, unless an extension is granted by the Court. While this ruling only applies in the province of Quebec, the Government of Canada has accepted the ruling and has committed to changing the MAID law for the whole country and plans to launch the full review of the MAID law this summer. Updating Canada's MAID law will expand eligibility for MAID beyond people who are nearing the end of life and could possibly result in other changes once the review is complete. Canadian Conference of Catholic Bishops has expressed their dismay regarding C-7, An Act to Amend the Criminal Code (medical assistance in dying). This C-7 Legislation seeks to expand the eligibility criteria for euthanasia and assisted suicide by removing the "reasonable forsee ability of natural death". If a person makes an advance directive to accept euthanasia, and later change their decision, they may not be able to communicate their refusal, making it difficult for medical practitioners and lawyers to decipher whether or not the patient still wishes to consent to the lethal procedure.

Let us continue to request from our government more palliative care and long-term care. We need to put more resources into other means of assisting people who are chronically ill or dying. Cardinal Thomas Collins on March 2, 2020 wrote an opinion article in the Toronto Star encouraging us to develop a culture of care. He also went on to say: "If all Canadians had access to quality palliative care, fewer would seek lethal injection. Instead of developing an overall culture of care, we are rushing towards death on demand. The same doctors who are trying to care for their patients will now be called on to approve euthanasia for them."

We should take time to be truly present to those who may feel that they are on the margins in our community. Those who feel that their life no longer has value must be assured by all of us that this is absolutely not the case — there is dignity within each human life, not just when we are young, healthy and able, but even more so, when we are fragile and vulnerable. The answer is not assisted death in its many forms; it is accompanying our family, our friends and even strangers to assist them in life, recognizing the inherent dignity of every person."

CWL Members are encouraged to be aware of this legislation, and we are fortunate to have a National and Provincial CWL Executive who will communicate to our Diocesan executive members, how to act and respond to legislation. I will be sharing these details with members.

RESOLUTIONS Karen McKibbon

Recently I had the pleasure of attending a Resolutions Workshop in Toronto to explore the background of writing resolutions.

Resolutions are a method and means to change a policy, express a concern about a piece of legislation or view regarding legislation. On the CWL National Website, going back as far as 1954, there are resolutions tabled for viewing. The Ontario CWL website, resolutions date back to 1982; both on a vast array of subjects.

It begins at the CWL parish level, when a member has an interest in a subject and chooses to share with her resolutions committee and progresses from that point. Thorough, reliable research must be performed. Canadian resources are necessary in our proven research. The resolution must be one page, as there is a short time frame to speak on it at the provincial and national conventions. We discovered that a current change to writing resolutions is: The whereas clause which was part of former resolutions will now become part of the brief. After the writing is completed by parish, there is a provincial review committee to "examine" the resolution.

It is important to share that CWL Members need only look to the government bills that relate to resolutions that have been approved and are posted on CWL websites. When writing to our governments regarding a resolution, members write on their own behalf.

I will be sharing with CWL members our letter writing plans on CWL resolutions listed below, that can help demonstrate the Catholic Women League, as a culture of "caring" individuals. I encourage your participation.

ON.19.03 Long Term Care Beds in Ontario
ON.16.01 Enhance the Canada Health Care Act to Include Home Care
2016.04 Amend the Canada Health Care Ace to Identify Palliative Care as an Insured
Health Service

In the fall communique from National, Spiritual Development Chair Shari Guinta, informed us that Pope Francis named October 2019 Extraordinary Missionary Month. The League is aware that mission work is very important as missionaries proclaim the Word of God in the most remote and in-need areas. The Apostles were the first missionaries. In Canada, French missionaries accompanied the explorers and continued this action. Encouraged by Pope Francis "Canadian Home Missions" need our attention by either prayers or monetary donations. The League has a permanent national voluntary fund for Catholic Missions in Canada.

The national Council made a motion at the National Convention in Calgary in August 2019 to establish a Day of Prayer for Canadian Home Missions. At present we await these plans. (Since the report was filed Shari Guinta has posted a Communique 8 indicating October 1st as the League's Day of Prayer for Canadian Home Missions and that information will be sent out in the Spring Parish Mailings.)

The Provincial Spiritual Development Chair, Emma Rose Rayburn, in her January communique informed the members that each diocese picks a different Diocesan Council each month as a prayer partner. In June, the Pembroke Diocese will pray for all our other Diocesan Sister Councils in Ontario.

In her February communique, Emma Rose Rayburn encourages all members to get ready for the coming of the Lord by preparing ourselves for the next 40 days (Lent) by giving of ourselves to each other. We can put down our phones, have a conversation with our parents, our children, our grandchildren and our neighbor. Another good way is to say the rosary together.



TREASURER Nancy Guyea

One of the many challenges in accepting a new position, in my case as treasurer, is you must attempt to do the job you accepted well and in a timely manner.

Essentially the role of treasurer is:

Paying bills

Reporting financial information

Preparing a budget

Keeping track of banking information and cheque books

As treasurer, you play an important role in your council's ability to carry out service projects, fundraisers and support The Catholic Women's League.
